OAKFIELD CHILD CARE QUARANTINE GUIDELINES

With the support of the Oakfield School District, changes have been made to the Safe Return to Oakfield Child Care Center Guidelines to better support the children and families of the Oakfield Child Care. This also continues to incorporate the Wisconsin State Licensing Child Care requirements.

*The quantity of positive cases in the child care could affect changes to this plan at any time.

- **Child tests POSITIVE for COVID-19**
 - Individual needs to quarantine for 5 days after test date. Day of test is day 0.
 - If the child can wear a mask, they can return to childcare on day 6 but will need to be masked until day 11. If new symptoms appear or a fever, individual can not return to childcare until fever free for 24 hours without the use of medicine and symptoms start improving
 - Testing options for positive results: a rapid test, PCR test, or an “at home” test kit done by parent with the observation of a child care director

- **Child is in CLOSE CONTACT with someone who tests positive (HOUSEHOLD)**
 - Child needs to quarantine for the 5 days the positive household individual needs to quarantine for AND then an additional 5 more days after for a total of 10 days and **THEN...**
 1. The child can get **tested** on day 5 of their own quarantine and return to childcare on day 6 with a negative test result and no symptoms. We highly recommend the child to wear a mask for the next 5 days, if possible
 - a. Testing options: Any rapid or PCR test done at a testing site) (Name, date, and results must be present on the info you send to us from the testing site) or an at-home test, done by a parent in the directors’ office and supervised by a director

OR

 - 2. The child can return to child care on day 6 and will be **REQUIRED to wear a mask for the next 5 days** and have no symptoms

OR

 - 3. If **no test is done and the child isn’t able to mask**, the child will need to quarantine for 10 days once the positive household member’s 5 day quarantine ends (a total of 15 days of quarantine starting the day of the positive test)
 - If the child is doing option 1 or 2 and start showing any symptoms after returning, they will be unable to attend childcare and will need to be tested/tested again before being able to return
 - We will accept at home tests if they were done in our office under our supervision, and any other tests that were done at testing sites (Name, date, and results must be present on the info you send to us from the testing site)

- Child is in **CLOSE CONTACT** with someone who tests positive (**Child Care Case**)
 - Individuals **who were not wearing a mask at the time of contact** need to quarantine for the 5 days after the close contact **THEN**
 1. The child can get **tested** on day 5 of their own quarantine and return to childcare on day 6 with a negative test result and no symptoms. We highly recommend the child to wear a mask for the next 5 days, if possible
 - a. Testing options: Any rapid or PCR test done at a testing site) (Name, date, and results must be present on the info you send to us from the testing site) or an at-home test, done by a parent in the directors' office and supervised by a director

OR

 - 2. The child can return to child care on day 6 and will be **REQUIRED to wear a mask for the next 5 days** and have no symptoms

OR

 - 3. If **no test is done and the child isn't able to mask**, the child will need to quarantine for 10 days after the last day of contact with the positive individual
 - If the child is doing option 1 or 2 and start showing any symptoms after returning, they will be unable to attend childcare and will need to be tested/tested again before being able to return
 - Individuals **who were wearing a mask at the time of contact** do not need to quarantine but will need to wear a mask for 10 days after the last day of contact with the positive individual. If symptoms appear, the child would need to begin quarantine
- **"At-home"** testing guidelines
 - Due to the limited amount of supplies available at testing sites, the At-Home testing has been made available **ONLY** for child care children birth to 3.
 - **The test needs to be taken in the directors' office with a director present**
 - Parents will need to provide the test, and will need to do the test on their child/ren
 - At-home tests must be completed onsite between 8:00 AM - 9:00 AM daily (hours may vary based on the availability of the directors)
 - The directors will manage a sign-up for this service, which needs to be scheduled with a director at least 24 hours in advance via a phone call or email.
 - Children over three years old will need to use the testing site run by Oakfield School District between 7:00 AM - 9:00 AM daily, until further notice. If testing is unavailable through this site, the at home testing guidelines mentioned above can be used
 - This is preferred because it will be recorded in the State Database.

- A parent must be present for the testing, and sign-up their child using the information below.

REGISTER FOR TESTING/SCHEDULE YOUR TEST

1. Go to <https://trackbynovir.com/login>
 2. Organization code: 2001
 3. Create an account as the parent/guardian
 4. Follow the steps and answer the questions as if you were being tested.
 5. Once completed, add family members. Answer the same questions for them.
- **CLOSE CONTACT** that has had a positive COVID-19 test result in the **PAST 90 DAYS**
 - Child does not need to be quarantined unless any new symptoms appear. If symptoms appear, child will need to follow the quarantine guidelines above
