

### Work we are doing

We have received the parent, student, and staff feedback from the School Perceptions survey you filled out in October. The information we received in these surveys have given us helpful direction to guide our staff actions in the next few months ahead. I will give an overview of the survey results as well as our action plans at the next Parent-Principal Meeting scheduled for December 13, 2023 at 6:00. Thank you for your input and responses to help make our district better!

There was much to be excited about with our Middle and High School report cards. Our overall district report card is the strongest in the county, our achievement levels are among the highest with our surrounding districts, and we excelled in the area of post-secondary readiness. We do, however, need to continue our focus on academic growth. Here is where we have been putting our efforts over the past months and will continue to be our focus throughout the remainder of this school year. To help with these efforts, we will have all students in grades 9-11 take the Naiku Pre-ACT assessment late January. This assessment will guide instruction practices while helping prepare all our students to reach the college and career readiness level, especially our juniors as they prepare post high school success.

Similarly, our middle school staff will also complete a deep dive into middle school testing and growth. Instead of the ACT test, the middle school will focus on the iReady results from the tests they completed in early September and compare scores from iReady tests they will take in January. The results will be analyzed and the middle level staff will be given specific training and tools to focus on the academic growth of our middle school students.





Hunters registered 173,942 deer during the 2023 Wiscosnsin gun deer season, including 85,390 antlered and 88,552 antlerless deer.

# Vietnam Veterans Visit OHS US History

We were fortunate to have three Vietnam Veterans visit the US History class on November 14th. Around Veterans Day, we cover a unit on the Vietnam War and invite veterans to our class. John Laudolff of the Byron area has always been willing to come to class. This year he brought in friends and fellow veterans Ric Bloohm and Ron Tagliapietra, both from the Lomira area. Students worked together to write summaries of what they found most interesting. Thanks to our veterans for their service to our country.

We are very grateful that the vets took the time out of their days to come and talk to us about the war. We learned a lot of things and were influenced by their stories. Some things we learned were that along with their regular rations they would also get special treats like candy bars from name brands like butterfingers, baby ruths and hershey. They would also get packs of cigarettes with their food which we found fairly surprising as it's not even food. A story that influenced us was the one about Ric's friend going home, it was an extremely emotional story and you could see that this person was important to him, upon finding out that he had killed himself as well just added another level of emotions on top of it because he never got to keep in contact with someone he was close to. Something we didn't know originally was that their helmets were actually separate pieces that could be put together, we also learned that they would draw on the helmets, things like random quotes and pictures, all of the helmets sported a peace sign in some place on the outside. These are a few of the things that we learned from and about the Vietnam veterans. (August Shepherd & Sydney *Machmueller*)

knowing it because you couldn't tell which were Vietcongs and who wasn't. Some things that were interesting was how they wrote messages on their helmets such as the Peace symbol and "Home is Wisconsin," which was just a way to help personalize their gear and set the stuff apart.

They also said how they had a limited candy selection of Butterfingers and Baby Ruth's and the occasional little Hershey's in their C Rations. It was cool how they showed some of the stuff that came in the C rations and went over the 12 different C Rations such as the "ham and lima beans," and the spaghetti and seasoned beef ones.

A thing that we learned was that most people were drafted within 2 years of graduating High School unless you went to college. We also learned that they would usually wear the liners of their helmets for parades usually since they were lighter. We also learned that they had an easy time adjusting to society after the war since they were from a small community and they could blend in which made it easier unlike living in a larger city with all the protests. We learned a lot about Vietnam from the guest speakers that came in. One of the things that stuck out to us the most was Ric's story on his time in the war with his best friend. This story stuck with us because it helped us to better understand what a day in the war was like, and how personal bonds can be made when put into that situation, and how dreadful it is when you are separated from someone that has become almost family. Another thing we learned about was the meal situation that they had. The meals that they had were very limited in the variety of food, only having their main meal, a bread roll, and a dessert. They also got a salt and pepper packet, and a napkin that they could use as toilet paper. The bathroom situations were definitely not as nice as what we have here. They had toilets but most of the time, they had to dig out of the ground with a shovel and do their business and then cover it backup with dirt. The other story that we remember well, is the story that John told about when he got shot, and the grenade. We remember him talking to us about what he was thinking at that moment, and about his recovery. It's mind boggling that it took 6-8 months for him to recover, but we also cant even fathom what it would be like to get injured that severely. His Forrest Gump impression help to lighten up his story and make us laugh.

One thing that they helped us to understand better was the draft/selection process that they went through. Ric and Ron especially helped us with telling us their perspective from when they got drafted, and going down to the selective service and putting their name on the draft board. They also explained to us the difference between the draft, and the lottery. John told us about enlisting, and how it worked differently.

We did not know that the civilians were fighting along with US soldiers and were sympathetic to the north. It was amazing that people with language barriers can overcome that and work together. Ric explained it very well and we learned something from it. Another story that we found very compelling is the one that Ric told about his friend that was serving with him that had a Vietnamese girlfriend, and children. His friend eventually left the military, but he also left his girlfriend and children with it. He started out sending money to his girlfriend, but even that began to come less and less. Ric soon found out that his friend killed himself after getting home from war. (Victoria Stahmann, Rhyan Vielbig and Daranee Xiong)

The veterans that came in told lots of

interesting stories about stuff from the war. Something that we found interesting was the story of John and when he got injured which showed that not everyone was lucky to come out unharmed but that he was also one of the few that came back from injuries. They also said how the Vietcong were in the camps without about Vietnam. This year he brought two friends to share their experiences.

...Another point that stuck out to me was when John got hit with shrapnel from a hand grenade. He also mentioned that the recovery took about 7-8 months and once he recovered he got redeployed. The final thing that stood out to me when I asked how it was to readjust once they got back home, John mentioned that Ron and himself went to a minor bar for 18 year olds. He also said that they ordered two Pabst Blue Ribbon beers. He mentioned that when they were sitting there listening to the jukebox and looking around and the other kids in there had no idea what they just had to go through in Vietnam. (*Dane Phillips*)

I learned about the food they ate, which ones they usually disliked and how the best food was just canned fruits...The food seemed pretty gross, and bland, definitely not filling. They mentioned that the Vietnamese wore "black pajamas", which I learned was not literal. Instead it was that the typical citizens wore very light and baggy clothes, typically they were black. A story that stood out to me was the one about the dog. That the soldiers found a way to brighten their days a little more with a sweet puppy around the base. Sadly not everyone liked the dog, and what was a joke at first, accidentally became reality. A soldier that wasn't very fond of the dog mistakenly shot him. They had also brought up how most of them smoked cigarettes, and they got a pack of four with every meal. It was intriguing to learn how heavily smoking was pushed onto such young people. It was interesting though, to hear the different ways the soldiers would entertain themselves. (Peyton Lamb)

One interesting story that we heard about was the story of how John got injured by a grenade and then told us about how long it took to recover and then where he went after he recovered (Mediterranean). Another interesting thing I learned from them was about the draft. They pretty much said they knew they were going to be drafted because a lot of their friends have already been drafted. They received a letter in the mail that said you have been chosen by your family and neighbors to go to war. They explained how it worked and how they put a bunch of names in a bin and picked out names to be selected. Another interesting thing that they talked about was all the new equipment that they

were given when they went to Vietnam. They got new guns, boots, and fatigues. Another thing they talked about was the different meals that they had. They had some different entrees and fruits and sorts of stuff like that. It was 2400-2800 calorie meals. They mentioned scrambled eggs and how they were bad because they were cold. The last thing that we found most interesting about John and Ron's experience was when they returned they went to a bar. They ended up leaving because they didn't feel like they fit in anymore. They described it as a very weird feeling. It was a bar that they went to before the war and had no problem fitting in, so it was strange to hear that when they came back they didn't fit in. The guest speakers were very interesting and we learned a lot from them. What Alex and I found most interesting about the guest speakers' experiences was the dog story that Ric Bloohm told. The story was about a dog that he and his fellow soldiers had taken in and fed. One soldier didn't like the dog, and had pointed his gun at the dog. He pulled the trigger thinking the mag was empty, but was caught by surprise when a bullet came out and went right through the dog's left shoulder. Another thing we found interesting was the meals they were eating. They were given four cans of food a day, that consisted of turkey, ham, beef, peaches, fruit cocktail, beans, and bread. Another interesting component

to the meals was the 4 cigarettes that were included in each meal. A fourth thing we found interesting was that Ron was a platoon leader and 1st lieutenant. One last thing we found interesting about the Veterans and their experiences in the Vietnam War was how young all of the soldiers were. Over half of the Vietnam Soldiers killed were 18 years old. Overall, the Veterans coming in helped us get a glimpse of what it was like serving in the Vietnam War, and we all learned a lot about their experiences. (Jorja Hofman and Alex Erber)

Caden and I learned many things, but one thing that stuck out to us was the food that they ate in Vietnam. We noticed that the MRE's were different from the ones today. Back then, the food was in canisters but nowadays it is in bags. We also found it interesting that there were cigarettes in each MRE. We remember them saying that they were always excited to get to the fruit because it was like a dessert. We remember Ric saying that the food was still in the MRE's, we found that interesting since it has been soooo many years. The last thing that really stood out to us about their food was that a can opener came with it and that they had to manually open it. Ric even let a few students try it, the one that students used was even from Vietnam! In the end, we really appreciated them coming and telling us about the Vietnam war. 
